

## **SUMMARY ANNUAL REPORT**

### **For Muhlenberg College Benefit Plan**

This is a summary of the annual report of the Muhlenberg College Benefit Plan, EIN 23-1352664, Plan No. 501, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Muhlenberg College has committed itself to pay certain self-insured Medical, and Stop Loss claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with United Concordia Insurance Company, Highmark Inc., Integrated Behavioral Health, and The Lincoln National Life Insurance Company to pay Dental, Vision, Life Insurance, Long-term Disability, Accidental Death and Dismemberment, and Employee Assistance Program claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$418,792.
